Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, 18ct yellow and white gold, diamond set, multistone ring. Plain, wide, flat, tapered band, measures 3.16mm width (at base) x 0.75mm depth, with curved underrail.

Feature, "vintage style solitaire" with shoulder stones. Coprising, a white gold setting to top, with beaded ribbon motif shoulders. Housing to centre one round brilliant cut diamond, claw set. The extended shoulders, each contain two single cut diamonds, bead set. The yellow gold band tapers up wide to the top, from both sides, underneath the white gold settings.



Polished finish, stamped "18ct UNITY 424" - acid tested as 18 carat gold. Finger size = S.

The ring contains;

One claw set round brilliant cut diamond, clarity is "Si", colour is "H", medium cut quality.

Dimensions = 3.46mm (Diameter) x 2.11mm (D-estimated)

Total Weight = 0.16ct (estimated - see NOTE below).

Four bead set single cut diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed), medium cut quality.

Dimensions = 1.35mm (average diameter)

Total Weight = 0.04ct (estimated - see NOTE below).

Total Item Weight = 3.97 grams, Total Gemstone Weight = 0.20ct, Total Metal Weight = 3.93 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
