Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's 2pce ring set (fused), hand-assembled raised, 18ct yellow and white gold, diamond set, solitaire ring. Plain, wide, low half round, tapered band, combined basal width 3.50mm x 0.94mm depth, with curved underrail.

Feature, "2pce ring set (fused together)". Comprising, a two tone solitaire & plain yellow gold band. Housing one round brilliant cut diamond, claw set in white gold. The extended shoulders, of the solitaire, taper up, split to each side of the central setting. Plain band fused to one side.

Polished finish, stamped "750, RRP (faded)" - acid tested as 18 carat gold.

Finger size = N1/2.

The ring contains;

One claw set round brilliant cut diamond, clarity is "Si", colour is "H", medium cut quality.
Dimensions = 3.65mm (Diameter) x 2.05mm (D-estimated)
Total Weight = 0.17ct (estimated - see NOTE below).

Total Item Weight = 3.35 grams, Total Gemstone Weight = 0.17ct, Total Metal Weight = 3.32 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar 2pce ring set (fused), employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
