## Valuation for Traditional Retail Insurance Replacement

### Item 1

One lady's, hand finished raised, 18ct white gold & diamond set, cluster ring. Plain, narrow, low half round, tapered band, measures 1.71mm width (at base) x 1.45mm depth, with curved underrail, open back settings, underneath.

Feature, "cluster style" ring design. Comprising, a raised three claw setting to top, houses one, pear cut, faceted, diamond, claw set. Drops to a double surround, containing thirty three round brilliant cut diamonds, claw set. The extended shoulders, of the band, tapers up slightly to the top, from both sides.

Polished finish, stamped "750, SS (symbol)" - acid tested as 18 carat gold.

Finger size = K.

The ring contains;

One claw set pear-cut, faceted, diamond, clarity is "Si", colour is "H", medium cut quality.  
Dimensions = 4.93mm (L) x 2.96mm (W) x 1.81mm (D-estimated)  
Total Weight = 0.15ct (estimated - see NOTE below).

Thirty Three claw set round brilliant cut diamonds, clarity is "Si", colour is "H", medium cut quality.  
Dimensions = 1.15mm (average diameter) x 0.70mm (D-estimated)  
Total Weight = 0.20ct (estimated - see NOTE below).

Total Item Weight = 3.43 grams, Total Gemstone Weight = 0.35ct, Total Metal Weight = 3.36 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
