Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, diamond set, multistone, 'heart' shaped necklet, of hand-assembled construction.

Feature stylised open 'heart' shaped pendant, with an oval elongated bail. There are a total of one hundred and sixty-six round brilliant cut diamonds, pave set. The settings are enclosed with a pierced underrail. The pendant is suspended from an oval 'belcher' style link chain with a small parrot clasp.

Chain dimensions = 46.00cm (ave. length) x 1.58mm (ave. width).

Pendant dimensions = 27.00mm (ave. length) x 19.92mm (ave. width) x 2.93mm (ave. depth).

Polished finish.

Stamped '750 18K ANTON *884 VI' - acid tested as 18 carat gold.

The necklet contains:

One Hundred And Fifteen pave set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to J" (mixed).

Dimensions = 1.05mm(Dia) x 0.64mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.40mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.04ct (estimated - see NOTE below)

Fifty One pave set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to I" (mixed).

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.87mm(Dia) x 1.14mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.87ct (estimated - see NOTE below)

Total Item Weight = 7.56 grams Total Gemstone Weight = 1.91ct Total Metal Weight = 7.18 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar necklet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
