Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, 9ct yellow gold & diamond set, cluster ring. Plain, narrow, low half round, tapered band, measures 1.43mm width (at base) x 0.86mm depth, with curved underrail, open back settings, underneath.

Feature, "cluster style" ring design. Comprising, a raised four claw setting, with a rhodium plated illusion plate to centre, houses one round brilliant cut diamond, illusion claw set. Drops to a circular shaped surround, containing sixteen, round brilliant cut diamonds, claw set. The extended shoulders, of the band, tapers up to pointed end terminations, to both sides.



Polished finish, unstamped - acid tested as 9 carat gold. Finger size = M.

the ring contains;

One illusion claw set round brilliant cut diamond, clarity is "P1", colour is "H", medium cut quality.

Dimensions = 3.70mm (Diameter) x 2.26mm (D-estimated)
Total Weight = 0.18ct (estimated - see NOTE below).

Sixteen claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 0.90mm (average diameter) x 0.55mm (D-estimated)
Total Weight = 0.07ct (estimated - see NOTE below).

Total Item Weight = 2.14 grams, Total Gemstone Weight = 0.25ct, Total Metal Weight = 2.09 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
