Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct yellow gold and rhodium plated, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 1.83mm in width (at base) x 1.03mm depth, with hollow and open back (drilled) setting.

Feature 'curved' single row ring design, housing seventeen round brilliant cut diamonds, tapering in size, secured in shared claw settings. Rhodium plating inside the setting area.

Polished finish.

Stamped '10K 0.25 TDW michael hill' - acid tested as approximately 10 carat gold.

Finger size is L 1/2.

The ring contains:

Seventeen claw set round brilliant cut diamonds, clarity 'P1 & P2' (mixed), colour 'H'.

Dimensions = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.75mm(Dia) x 1.07mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.25ct (estimated - see NOTE below)

Total Item Weight = 2.30 grams

Total Gemstone Weight = 0.25ct

Total Metal Weight = 2.25 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
