Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct white gold, cluster style, gem set, dress ring, of cast construction.

Plain, narrow, tapered band of 1.74mm in width (at base) x 1.08mm depth, with a curved underrail.

Feature four claw 'cluster' style ring design, with wire 'scroll' style sides, housing one round brilliant cut diamond to the centre, surrounded by eight single cut diamonds, all claw set. Secured between the extended shoulders of the plain and polished band.

Polished finish - stamped '14K KRN' - acid tested as 14 carat gold. Finger size is P 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity 'P2', colour 'H'.

Dimensions = 5.02mm(Dia) x 3.06mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.50ct (estimated - see NOTE below)

Eight claw set single cut diamonds, clarity 'Si & P1' (mixed), colour 'G to I' (mixed).

Dimensions = 2.65mm (average diameter)

Total Weight = 0.52ct (estimated - see NOTE below)

Total Item Weight = 4.02 grams

Total Gemstone Weight = 1.02ct

Total Metal Weight = 3.82 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
