Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand finished, 18ct white gold, multistone, gem set ring.

Plain, wide, parallel band of 11.65mm at top to 11.40mm in width (at base) x 1.80mm depth, with open back (drilled) settings.

Feature three row ring design, housing forty-five round brilliant cut diamonds, tapering in size, claw set. A fine groove to each side, around the outer circumference of the band, forming fine rails.

Polished finish.

Stamped '750 ANTON' - acid tested as 18 carat gold.

Finger size is T.

The ring contains:

Forty Five claw set round brilliant cut diamonds, clarity 'Vs & Si' (mixed), colour 'G'.

Dimensions = 2.65mm(Dia) x 1.62mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.75mm(Dia) x 1.68mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 3.00ct (estimated - see NOTE below)

Total Item Weight = 22.39 grams

Total Gemstone Weight = 3.00ct

Total Metal Weight = 21.79 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
