## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, hand-assembled, 18ct yellow gold, articulated, gem set necklet.

Feature open back round-shape bezel setting, housing one round brilliant cut diamond, rubover set. A curved bar is secured to the top, then articulated from the diamond cut 'trace' style linkage design chain. A small 'bolt' ring type clasp fitted.

Polished finish.

Unstamped - acid tested as 18 carat gold.

Chain dimensions = 45.00cm (length including clasp) x 1.15mm (ave. width). Pendant dimensions = 8.15mm (length) x 16.60mm to 6.40mm (width).

The necklet contains:

One rub over set round brilliant cut diamond, clarity 'Si', colour 'G'.

Dimensions = 3.60mm(Dia) x 2.10mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.17ct (estimated - see NOTE below)

Total Item Weight = 3.51 grams Total Gemstone Weight = 0.17ct Total Metal Weight = 3.48 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar necklet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
