

Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct yellow gold, multistone, gem set ring, of cast construction. Plain, narrow, tapered band of 1.82mm in width (at base) x 1.23mm depth, with curved underrail.

Feature central three claw setting, with pierced base support, housing one pear-shape brilliant cut diamond, claw set. Surrounded by fourteen single cut diamonds, claw set. Secured between the extended shoulders of the plain and polished band. Each shoulder having eight single cut diamonds, tapering in size, also claw set.





The ring contains:

One claw set pear- shape diamond, clarity 'P3', colour 'H'.

Dimensions = 4.00mm(L) x 2.50mm(W) x 1.50mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.10ct (estimated - see NOTE below)

Thirty claw set single cut diamonds, clarity 'Si', colour 'H'.

Dimensions = 0.70mm(Dia) (smallest)

Dimensions = 1.10mm(Dia) (largest)

Total Weight = 0.10ct (estimated - see NOTE below)

Total Item Weight = 1.96 grams - Total Gemstone Weight = 0.20ct - Total Metal Weight = 1.92 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
