Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, 18ct yellow gold & diamond set, cluster ring. Plain, narrow, low half round, tapered band, measures 1.64mm width (at base) x 0.75mm depth, with curved underrail, open to back.

Feature, "navette shaped cluster" step down, contains total ninety one, round brilliant cut diamonds, various sizes, all claw set. The extended shoulders, of the band, tapers up wide, splits to three rails to each side.

Polished finish, stamped "K18, 1.00" - acid tested as 18 carat gold. Finger size = Q.

The ring contains;

Ninety One claw set round brilliant cut diamonds, clarity is "Si", colour is "light brown tint", medium cut quality.

Dimensions = 1.20mm (average diameter) x 0.73mm (D-estimated) (smallest)

Dimensions = 1.80mm (average diameter) x 1.10mm (D-estimated) (largest)

Total Weight = 1.00ct (estimated - see NOTE below).

Total Item Weight = 3.71 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 3.51 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
