## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's hand finished raised, 18ct white gold & diamond set ring, of cast construction.

Plain, narrow, low half round, tapered band, measures 1.80mm width (at base) x 1.17mm depth, with curved underrail.

Feature, 'solitaire style' design. Comprising, a raised six claw setting, houses one round brilliant cut diamond (laser inscribed), claw set. The extended shoulders, of the band tapers up to the base of the setting, from both sides.

Polished finish, stamped "18K, michael hill, 48227200124" - acid tested as 18 carat gold.

Finger size = K1/2.

The ring contains;

One claw set round brilliant cut diamond (laser inscribed), clarity is "Si", colour is "G", medium cut quality.  
Dimensions = 4.45mm (diameter) x 2.71mm (D-estimated)  
Total Weight = 0.33ct (estimated - see NOTE below).

Total Item Weight = 2.16 grams, Total Gemstone Weight = 0.33ct, Total Metal Weight = 2.09 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. Note the round brilliant cut diamonds, has a laser inscription upon read s as 'michael hill 48227200124'. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
