### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 18ct yellow gold and platinum, diamond set, 'three stone' style ring, of handmade construction.

Plain, narrow, low half round band of 1.73mm width (at base) x 1.03mm depth, with open back settings, and a curved underrail.

Feature 'vintage' style ring, with a central square platinum four claw setting, housing one round brilliant cut diamond, claw set. There is a pierced decorative gallery, and engraved and millegrain detail. Each of the shoulders is embellished with one single cut diamond, claw set.

Polished finish.

Stamped 'PLATINUM' - acid tested as 18 carat gold and platinum.

Ring size: K.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "G".

Dimensions = 3.98mm(L) x 3.97mm(W) x 2.41mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.24ct (estimated - see NOTE below)

Two claw set round brilliant cut diamonds, clarity is "Vs", colour is "H to I" (mixed).

Dimensions (average) = 1.46mm(Dia) x 0.89mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.03ct (estimated - see NOTE below)

Total Item Weight = 2.19 grams Total Gemstone Weight = 0.27ct Total Metal Weight = 2.14 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
