Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct white gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 1.94mm width (at base) x 0.80mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature central four claw setting, housing one emerald cut natural aquamarine, claw set. Surrounding is two rows, with a total of fifty-two single cut diamonds, claw set. The top plate is supported with an open wire base, and is secured to the underrail and in between the 'split' style shoulders, of the plain and polished band.

Polished finish.

Stamped '10K HN' - acid tested as 9 carat gold.

Ring size: N 1/2.

The ring contains:

One claw set emerald cut natural aquamarine, colour is "blue".

Dimensions = 8.12mm(L) x 5.97mm(W) x 3.70mm(D-estimated)

Total Weight = 1.22ct (estimated - see NOTE below)

Fifty Two claw set single cut diamonds, clarity is "P2 & P3" (mixed), colour is "H to I" (mixed).

Dimensions = 1.30mm (diameter) (smallest)

Dimensions = 1.40mm (diameter) (largest)

Total Weight = 0.57ct (estimated - see NOTE below)

Total Item Weight = 3.71 grams Total Gemstone Weight = 1.79ct Total Metal Weight = 3.35 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
