Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, flat, tapered band of 2.79mm width (at base) x 0.91mm depth, with open back settings, and a curved underrail.

Feature central four claw setting, housing one emerald cut natural emerald, claw set. Surrounding is one row twelve round brilliant cut diamonds, claw set. The top plate is supported with an open wire base, and is secured to the underrail, and in between the extended and square shoulders, of the plain and polished band.

Polished finish.

Stamped '18CT' - acid tested as 18 carat gold.

Ring size: Q.

The ring contains:

One claw set emerald cut natural emerald, colour is "green".

Dimensions = 5.90mm(L) x 5.60mm(W) x 4.55mm(D-estimated)

Total Weight = 1.02ct (estimated - see NOTE below)

Twelve claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions = 1.98mm(Dia) x 1.21mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.15mm(Dia) x 1.31mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.42ct (estimated - see NOTE below)

Total Item Weight = 5.14 grams Total Gemstone Weight = 1.44ct Total Metal Weight = 4.85 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
