Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, raised 9ct yellow gold & gemset, cluster ring, of cast construction. Plain, narrow, low half round, tapered band, measures 2.28mm width (at base) x 1.35mm depth, with cut-out underrail, open back setting, underneath.

Feature, "cluster style" ring design. Comprising, an oval-shaped, cluster basket setting to top. The extended shoulders, of the band, taper up to pointed end terminations to both sides.

Polished finish, stamped "375" - acid tested as 9 carat gold. Finger size = I.

The ring contains;

One claw set oval-shaped, faceted, synthetic ruby, colour is "medium dark red".
Dimensions = 7.00mm (L) x 5.00mm (W) x 3.09mm (D-estimated)
Total Weight = 0.89ct (estimated - see NOTE below).

Sixteen claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.
Dimensions = 1.40mm (average diameter) x 0.85mm (D-estimated) (smallest)
Dimensions = 1.50mm (average diameter) x 0.92mm (D-estimated) (largest)
Total Weight = 0.21ct (estimated - see NOTE below).

Total Item Weight = 2.57 grams, Total Gemstone Weight = 1.10ct, Total Metal Weight = 2.35 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
