Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.22mm width (at base) x 1.27mm width, with open back settings.

Feature assymetrical cluster comprising of five oval natural sapphires, and seven single cut diamonds, all claw set. The settings are secured between the extended and pointed 'split' style shoulders, of the plain and polished band.

Polished finish.

Stamped '* 18K' - acid tested as 18 carat gold.

Ring size: M 1/2.

The ring contains:

Five claw set oval shaped natural sapphires, colour is "blue".

Dimensions (average) = 4.50mm(L) x 3.62mm(W) x 2.21mm(D-estimated)

Total Weight = 1.50ct (estimated - see NOTE below)

Seven claw set single cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 1.25mm (diameter)

Total Weight = 0.06ct (estimated - see NOTE below)

Total Item Weight = 4.81 grams Total Gemstone Weight = 1.56ct Total Metal Weight = 4.50 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
