Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, gem set, dress ring, of cast construction.

Plain, narrow, low half round, tapered band of 3.29mm width (at base) x 1.12mm depth, with open back settings, and a curved underrail.

Feature central cultured pearl, glue set. The setting is secured to the underrail, and in between the 'split' shoulders, in a 'wrap around' style, of the plain and polished band. Each of the shoulder terminations houses on row of five synthetic cubic zirconias, bead set.

Polished finish.

Stamped '9ct THU42' - acid tested as 9 carat gold.

Ring size: K 1/2.

The ring contains:

One end-drilled semi-round cultured pearl, colour is "black".

Dimensions = 10.20mm(L) x 9.83mm(W) x 9.80mm(D)

Ten bead set round synthetic cubic zirconias, colour is "colourless".

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Bulge) (smallest)

Dimensions = 2.00mm(Dia) x 1.22mm(D-estimated) x 2%(Bulge) (largest)

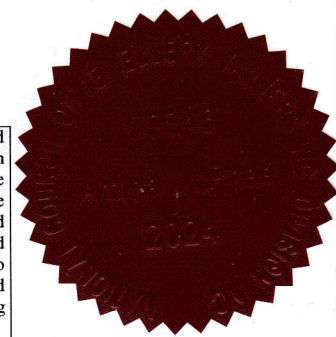
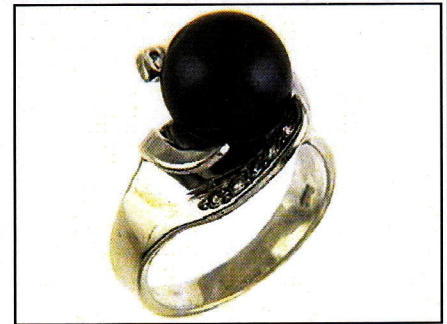

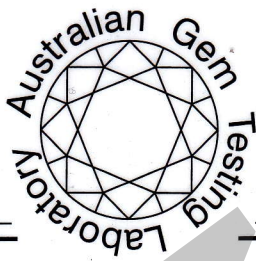
