Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'three stone' style ring, of cast construction.

Plain, narrow, low half round band of 3.61mm width (at base) x 0.90mm depth, with open back settings, and a decorative underrail.

Feature three decorative sweeping four claw settings, spanning across the top of the band, graduating in size, largest to the centre. Each setting housing one round brilliant cut diamond, claw set. The settings are secured between extended and square shoulders, of the plain and polished band. Each of the shoulders houses one row of three round brilliant cut diamonds, channel set.



Polished finish. Stamped '18K michael hill 1.00' - acid tested as 18 carat gold. Ring size: M 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P3", colour is "I".

Dimensions = 4.49mm(Dia) x 2.90mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.37ct (estimated - see NOTE below)

Two claw set round brilliant cut diamonds, clarity is "P2 & P3" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 4.09mm(L) x 4.08mm(W) x 2.60mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.51ct (estimated - see NOTE below)

Six channel set round brilliant cut diamonds, clarity is "P2 & P3" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.12ct (estimated - see NOTE below)

Total Item Weight = 5.32 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 5.11 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
