## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, pair of lady's, hand-assembled raised, 18ct yellow gold & gemset stud earrings.

Feature, stud cup, with a four claw extension, each contains one round cultured pearl, end drilled & glue set. One round brilliant cut diamond, claw set. Both earrings, come with plain post & butterfly fittings, attached.

Polished finish, stamped "750" - acid tested as 18 carat gold.

Earring dimensions = 11.00mm (total length) x 7.62mm (width) x 8.81mm (depth).

The earrings contain:

Two end-drilled round cultured white/pink pearls, lustre is "High-Medium", blemish is "Few blemishes", good matching.

Dimensions = 7.59mm (average diameter) (smallest)

Dimensions = 7.64mm (average diameter) (largest)

(estimated - see NOTE below).

Two claw set round brilliant cut diamonds, clarity is "Vs", colour is "H", medium cut quality.

Dimensions = 3.09mm (average diameter) x 1.88mm (D-estimated) (smallest)

Dimensions = 3.12mm (average diameter) x 1.90mm (D-estimated) (largest)

Total Weight = 0.20ct (estimated - see NOTE below).

Total Item Weight = 3.41 grams, Total Gemstone Weight = 0.20ct, Total Metal Weight = 3.37 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
