## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 9ct yellow gold, gem set, multistone, 'cluster' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 2.54mm width (at base) x 1.19mm depth, with open back settings, and a curved underrail.

Feature square top plate within a four claw setting, housing nine round brilliant cut diamonds, claw set. The setting is secured to the underrail, and in between the extended and square shoulders, of the plain and polished band.

Polished finish.

Unstamped - acid tested as approximately 9 carat gold.

Ring size: L.

The ring contains:

Nine claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions = 1.96mm(Dia) x 1.20mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.10mm(Dia) x 1.28mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.27ct (estimated - see NOTE below)

Total Item Weight = 3.13 grams

Total Gemstone Weight = 0.27ct

Total Metal Weight = 3.08 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
