### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, hand assembled, 14ct white gold, multi-stone, ring set, of cast construction.

The set comprising a 14ct white gold and diamond set engagement ring with a matching 14ct white gold diamond set wedding and eternity rings. Each ring having a plain, narrow, low half round, tapered band with a combined basal width of 4.06mm x 0.89mm in depth.

The engagement ring has a central four claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the top of the plain and polished band. Each of the shoulders houses one row of five round brilliant cut diamonds, claw set.



The matching wedding and eternity rings are identical. There is one row of ten round brilliant cut diamonds, spanning across the top of the band, slightly graduating in size, largest to the centre, claw set. The wedding and eternity rings sit alongside the engagement ring above.

Polished finish. Stamped 'MHJ 585 H10411 1.10 14K 23' - acid tested as 14 carat gold. Ring size: L.

The ring set contains:

One claw set round brilliant cut diamond, clarity is "P2", colour is "I".

Dimensions = 5.68mm(Dia) x 3.60mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.70ct (estimated - see NOTE below)

Ten claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 2.20mm(Dia) x 1.34mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.40ct (estimated - see NOTE below)

Twenty claw set round brilliant cut diamonds, clarity is "P2 & P3" (mixed), colour is "H to J" (mixed).

Dimensions = 1.55mm(Dia) x 0.95mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.65mm(Dia) x 1.01mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.34ct (estimated - see NOTE below)

Total Item Weight = 5.72 grams Total Gemstone Weight = 1.44ct Total Metal Weight = 5.43 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
