### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 14ct white gold and 14ct rose gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.13mm width (at base) x 1.16mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature round top plate, with a central four claw setting, housing one round brilliant cut diamond, claw set. Surrounding is one row of twelve round brilliant cut diamonds, claw set. The top plate is secured between the extended and pointed 'split' style shoulders, in a 'wrap around' style, of the plain and polished band. Each of the shoulder terminations, is embellished with a rose gold wire, and one row of eight round brilliant cut diamonds, graduating in size, and claw set.



Polished finish. Stamped '14K MHJ' - acid tested as 14 carat gold. Ring size: K 1/2.

#### The ring contains:

One claw set round brilliant cut diamond, clarity is "P3", colour is "H".

Dimensions = 3.73mm(Dia) x 2.48mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.22ct (estimated - see NOTE below)

Twelve claw set round brilliant cut diamonds, clarity is "P1 & P2 & P3" (mixed), colour is "H to I" (mixed).

Dimensions = 1.60mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.90mm(Dia) x 1.16mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.18ct (estimated - see NOTE below)

Twenty Two claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.29ct (estimated - see NOTE below)

Total Item Weight = 4.32 grams Total Gemstone Weight = 0.69ct Total Metal Weight = 4.18 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
