Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct white gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 2.16mm width (at base) x 1.28mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature central illusion setting, housing one round brilliant cut diamond, illusion set. Surrounding is one row of fourteen single cut diamonds, claw set. The top plate is supported with a decorative gallery, and is secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished band.

Polished finish.

Stamped '10K michael hill 0.25 TDW' - acid tested as approximately 10 carat gold.

Ring size: O.

The ring contains:

One illusion set round brilliant cut diamond, clarity is "P1", colour is "H".

Dimensions = 3.50mm(Dia) x 2.14mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.16ct (estimated - see NOTE below)

Fourteen claw set single cut diamonds, clarity is "Si & P1" (mixed), colour is "H to J" (mixed).

Dimensions (average) = 1.10mm (diameter)

Total Weight = 0.09ct (estimated - see NOTE below)

Total Item Weight = 2.02 grams Total Gemstone Weight = 0.25ct Total Metal Weight = 1.97 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
