Valuation for Traditional Retail Insurance Replacement

Item 1

One,18ct yellow gold and 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.41mm width (at base) x 1.03mm depth, with closed back settings.

Feature white gold top plate, housing one row of nine round brilliant cut diamonds, varying in size, and claw set. The top plate is secured between the shoulders of the plain and polished yellow gold band.

Polished finish.

Stamped '750 JP88' - acid tested as 18 carat gold.

Ring size: K.

The ring contains:

Nine claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H". Dimensions = 2.65mm(Dia) x 1.62mm(D-estimated) x 2%(Girdle Thickness) (smallest) Dimensions = 2.90mm(Dia) x 1.77mm(D-estimated) x 2%(Girdle Thickness) (largest) Total Weight = 0.72ct (estimated - see NOTE below)

Total Item Weight = 3.12 grams Total Gemstone Weight = 0.72ct Total Metal Weight = 2.98 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
