### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.35mm width (at base) x 1.21mm depth, with open back (cut out) settings, and a curved underrail.

Feature central square top plate, within a four claw decorative setting, housing four Princess cut diamonds, invisibly set. The setting is secured to the underrail, and in between the extended and square 'ramp' style shoulders, of the plain and polished band. Each of the shoulders houses one row of four Princess cut diamonds, graduating in size, and channel set.

Polished finish.

Stamped '18K 750 MHJ iS' - acid tested as 18 carat gold.

Ring size: H.

The ring contains:

Four invisibly set Princess cut diamonds, clarity is "Si", colour is "H to I" (mixed).

Dimensions (average) = 3.00mm(L) x 3.00mm(W) x 2.13mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.60ct (estimated - see NOTE below)

Eight channel set Princess cut diamonds, clarity is "Si", colour is "G to I" (mixed).

Dimensions = 1.80mm(L) x 1.80mm(W) x 1.28mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.40mm(L) x 2.40mm(W) x 1.70mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.47ct (estimated - see NOTE below)

Total Item Weight = 4.55 grams

Total Gemstone Weight = 1.07ct

Total Metal Weight = 4.34 grams (estimated)


NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
