Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand crafted raised, 18ct yellow gold & gemset, solitaire ring.

Plain, wide, half round, tapered band, measures 3.94mm width (at base) x 1.16mm depth, with cut-out underrail, open back setting, underneath.

Feature, "Art deco style" design. Comprising, a raised, squarish-shaped setting to top, houses one Old European cut diamond, bead set. The extended shoulders, of the plain band, tapers up, half way terminations, splits into four rails, to both sides.

Polished finish, stamped "crown 18 g" (circa 1922) - acid tested as 18 carat gold.

Finger size = P1/2.

The ring contains;

One bead set Old European cut diamond, clarity is "P2", colour is "I", medium cut quality.
Dimensions = 4.50-4.00mm (average diameter) x 2.24mm (D-estimated)
Total Weight = 0.26ct (estimated - see NOTE below).

Total Item Weight = 5.89 grams, Total Gemstone Weight = 0.26ct, Total Metal Weight = 5.84 grams (estimated)

Note; Limited gemmological testing, inset. The below replacement figure is based upon crafting a similar ring using all modern round brilliant cut diamonds of the same estimated weight, colour and clarity employing similar materials and techniques being for a retail insurance purpose only.
