Valuation for Traditional Retail Insurance Replacement

One, 18ct yellow gold, gem set, multistone ring, of hand-assembled construction.

Plain, wide, low half round band of 4.82mm width (at base) x 1.05mm depth, with open back settings.

Feature one row of five round brilliant cut diamonds, graduating in size, each housing one round brilliant cut diamond, end set. There is one groove to the top and bottom of the band, running the entire circumferance of the plain and polished band. The settings are secured to the top of the band.

Polished finish.

Stamped '18ct unknown makers mark' - acid tested as 18 carat gold.

Ring size: O.

The ring contains:

Five end set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed). Dimensions = 2.75mm(Dia) x 1.68mm(D-estimated) x 2%(Girdle Thickness) (smallest) Dimensions = 3.40mm(Dia) x 2.07mm(D-estimated) x 2%(Girdle Thickness) (largest) Total Weight = 0.33ct (estimated - see NOTE below)

Total Item Weight = 5.53 grams Total Gemstone Weight = 0.33ct Total Metal Weight = 5.46 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
