Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 2.14mm width (at base) x 0.74mm depth, with a hollow top and shoulders, and open back settings.

Feature dome shaped band, housing thirty-one round brilliant cut diamonds, graduating in size, largest to the centre, pave set. The settings are secured between the tapering shoulders, of the plain and polished band.

Polished finish.

Stamped '18K 75' - acid tested as 18 carat gold.

Ring size: J 1/2.

The ring contains:

Thirty One pave set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "H".
Dimensions = 1.72mm(Dia) x 1.05mm(D-estimated) x 2%(Girdle Thickness) (smallest)
Dimensions = 2.50mm(Dia) x 1.53mm(D-estimated) x 2%(Girdle Thickness) (largest)
Total Weight = 0.75ct (estimated - see NOTE below)

Total Item Weight = 3.08 grams
Total Gemstone Weight = 0.74ct
Total Metal Weight = 2.93 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
