## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's hand finished raised, 14ct white gold & gemset, multistone ring. Plain, narrow, low half round, tapered band, measures 2.55mm width (at base) x 1.41mm depth, with curved underrail, open back settings, underneath. Feature, Illusion solitaire style" ring design, with shoulder and rails stones. Comprising, a raised four claw settint to top, houses four Princess cut diamonds, illusion claw set. The extended shoulders, of the band tapers up, splits to three channel rows, Centre row both sides, contain nine tapered baguette cut diamonds, channel set. The two side rows, run across the top of the band, each containing nine round brilliant cut diamonds, channel set, both sides.



Polished finish, stamped "14K, 1.00 michael hill" - acid tested as 14 carat gold. Finger size = L1/2.

The ring contains;

Four illusion claw set Princess cut diamonds, clarity is "Si & P1"(mixed), colour is "G to I"(mixed), medium cut quality.

Average dimensions = 2.40mm (L) x 2.40mm (W) x 1.70mm (D-estimated)

Total Weight = 0.32ct (estimated - see NOTE below).

Eighteen channel set tapered baguette diamonds, clarity is "Vs & Si"(mixed), colour is "G to I"(mixed), medium cut quality.

Average dimensions = 1.60mm (L) x 0.90mm (W) x 0.66mm (D-estimated) (smallest)

Average dimensions = 2.40mm (L) x 1.40mm (W) x 1.02mm (D-estimated) (largest)

Total Weight = 0.28ct (estimated - see NOTE below).

Eighteen channel set round brilliant cut diamonds, clarity is "SI-P1", colour is "G-I", medium cut quality.

Dimensions = 1.40mm (average diameter) x 0.85mm (D-estimated) (smallest)

Dimensions = 1.90mm (average diameter) x 1.16mm (D-estimated) (largest)

Total Weight = 0.40ct (estimated - see NOTE below).

Total Item Weight = 6.06 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 5.86 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
