Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, 'three stone' style ring, of hand-assembled construction.

Plain, narrow, high half round, tapered band of 1.69mm width (at base) x 1.34mm depth, with open back settings, and a curved underrail.

Feature central white gold illusion setting, within a six claw setting, housing one early brilliant cut diamond, illusion set. The setting is secured between the extended and pointed shoulders, of the plain and polished yellow gold band. Each of the shoulders houses one single cut diamond, bead set.

Polished finish. Incorrectly stamped '18ct PLAT' - acid tested as 18 carat gold. Ring size: O.

The ring contains:

One illusion set early brilliant cut diamond, clarity is "Si2", colour is "J".

Dimensions = 4.89mm(L) x 4.82mm(W) x 2.8mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.41ct (estimated - see NOTE below)

Two bead set single cut diamonds, clarity is "Si", colour is "H to I" (mixed).

Dimensions (average) = 1.20mm (diameter)

Total Weight = 0.02ct (estimated - see NOTE below)

Total Item Weight = 3.13 grams Total Gemstone Weight = 0.43ct Total Metal Weight = 3.04 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
