Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct white gold, gem set, pendant, of hand-assembled construction.

Feature central articulated illusion setting, housing one round brilliant cut diamond, illusion set. Surrounding is one row of seventeen round brilliant cut diamonds, claw set. The pendant is finished with a fixed tapered bail, which has been embellished with one row of four round brilliant cut diamonds, claw set.

Pendant dimensions = 22.00mm (ave. length) x 13.00mm (ave. width) x 6.30mm (ave. depth).

Polished finish.

Stamped '14K MHJ 1.00 TDW 65 PCT 002357' - acid tested as 14 carat gold.

The pendant contains:

One illusion set round brilliant cut diamond, clarity is "P3", colour is "H".

Dimensions = 4.80mm(Dia) x 2.93mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.42ct (estimated - see NOTE below)

Twenty One claw set round brilliant cut diamonds, clarity is "P2 & P3" (mixed), colour is "H".

Dimensions = 1.90mm(Dia) x 1.16mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.00mm(Dia) x 1.22mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.58ct (estimated - see NOTE below)

Total Item Weight = 3.42 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 3.22 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
