Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, and rhodium plated, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.23mm width (at base) x 1.11mm depth, with open back settings, and a curved underrail.

Feature cushion shaped top plate, with a central four claw setting, housing one round brilliant cut diamond, claw set. Surrounding is two rows of round brilliant cut diamonds, claw set. The top plate is secured to the decorative gallery, and the 'split' style shoulders, of the plain and polished band. The shoulders are also embellished with round brilliant cut diamonds, claw set. There are a total of sixty round brilliant cut diamonds, varying in size. Rhodium plating to the diamond settings areas.

Polished finish. Unstamped - acid tested as 18 carat gold. Ring size: K.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P2", colour is "J".

Dimensions = 5.03mm(Dia) x 3.19mm(D-estimated) x 3.5%(Girdle Thickness)

Total Weight = 0.50ct

Sixty Six claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "I to J" (mixed).

Dimensions = 1.10mm(Dia) x 0.67mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.60mm(Dia) x 1.59mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 4.57 grams Total Gemstone Weight = 1.44ct Total Metal Weight = 4.28 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
