Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, 'three stone' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.14mm width (at base) x 0.75mm depth, with a curved underrail.

Feature central white gold six claw setting, housing one early brilliant cut diamond, claw set. Either side of the central setting, is one white gold four claw setting, each housing one old cut diamond, claw set. The settings are secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished yellow gold band.

Polished finish.

Stamped '750 illegible stamp' - acid tested as 18 carat gold.

Ring size: J.

The ring contains:

One claw set early brilliant cut diamond, colour is "H".

Dimensions = 4.80mm(L) x 4.72mm(W) x 2.97mm(D-estimated)

Total Weight = 0.40ct (estimated - see NOTE below)

Two claw set old cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 3.61mm(L) x 3.54mm(W) x 2.65mm(D-estimated)

Total Weight = 0.44ct (estimated - see NOTE below)

Total Item Weight = 2.79 grams Total Gemstone Weight = 0.84ct Total Metal Weight = 2.62 grams (estimated)

NOTE: The below replacement figure is based upon crafting a similar ring using all modern round brilliant cut diamonds of the same estimated weight, colour and clarity employing similar materials and techniques being for a retail insurance purpose only. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
