Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.54mm width (at base) x 1.31mm depth, with a curved underail.

Feature central six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured between the knife-edge shoulders, of the plain and polished band.

Polished finish.

Stamped '750 unknown makers mark' - acid tested as 18 carat gold.

Ring size: O.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si2", colour is "E".

Dimensions = 4.28mm(L) x 4.25mm(W) x 2.67mm(D-estimated) x 2.5%(Girdle Thickness)

Total Weight = 0.30ct (known weight - see NOTE below)

Total Item Weight = 2.54 grams

Total Gemstone Weight = 0.30ct

Total Metal Weight = 2.48 grams (estimated)



NOTE: The diamond has been certified by Messrs. Gemological Institute of America (GIA) Certificate number: 7286632993 Dated: Apr. 3, 2018. The diamond has also been laser inscribed upon the girdle with GIA (logo) and 7286632993. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
