Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, platinum & gemset, solitaire ring.

Plain, narrow, low half round, tapered band, measures 2.00mm width (at base) x with curved underrail.

Feature; "solitaire style" design. Comprising, a raised four claw setting to top, houses one oval-shaped, faceted, natural sapphire, claw set. The extended shoulders, of the band, tapers up to pointed end terminations, to the top, from both sides.

Polished finish, stamped "Plat" - acid tested as platinum.

Finger sizes = L.

The ring contains;

One claw set oval-shaped, faceted, natural sapphire, colour is "medium purple/violet".

Dimensions = 6.09mm (L) x 5.21mm (W) x 4.40mm (D-estimated)

Total Weight = 1.17ct (estimated - see NOTE below).

Total Item Weight = 5.14 grams, Total Gemstone Weight = 1.17ct, Total Metal Weight = 4.91 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weights of the gemstone are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstone require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
