Valuation for Traditional Retail Replacement

Item 1

One, lady's 2pce ring set, hand-assembled raised, 9ct white gold & multistone set rings. Plain, narrow, low half round, tapered band, measures 3.28mm combined basal width x 1.10mm depth, with curved underrail.

Feature "2pce ring set" comprising, an engagement ring, contains one raised four claw illusion setting, houses one round brilliant cut diamond, claw set. The extended shoulders, & side walls of the centrall setting, housing sixteen round brilliant cut diamonds, claw set. The complimenting side band, a single row across the top, containing fourteen round brilliant cut diamonds, claw set.

Polished finish, stamped "375" JP02, JP88 - acid tested both as 9 carat gold.

Finger size = V1/2.

The ring contains;

One illusion claw set round brilliant cut diamond, clarity is "P1", colour is "J", medium cut quality.
 Dimensions = 3.57mm (Diameter) x 2.18mm (D-estimated)
 Total Weight = 0.17ct (estimated - see NOTE below).

Thirty claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "I to J"(mixed), medium cut quality.
 Dimensions = 1.20mm (average diameter) x 0.76mm (D-estimated) (smallest)
 Dimensions = 1.62mm (average diameter) x 0.99mm (D-estimated) (largest)
 Total Weight = 0.38ct (estimated - see NOTE below).

Total Item Weight = 4.60 grams, Total Gemstone Weight = 0.55ct, Total Metal Weight = 4.49 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar 2pce ring set employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
