Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand finished raised, 9ct yellow and white gold, diamond set, multistone ring. Plain, wide, half round, ribbed, parallel band, measures 4.70mm width (at base) x 1.64mm depth, with curved underrail.

Feature, "two tone" ring design. Comprising, a raised channel setting to centre, houses seven round brilliant cut diamonds, channel set. The extended shoulders, run parallel to the top, from both sides.

Polished finish, stamped "9CT" - acid tested as 9 carat gold.

Finger size = S1/2.

The ring contains:

Seven channel set round brilliant cut diamonds, clarity is "SI & PI" (mixed), colour is "G to I" (mixed), medium cut quality.

Dimensions - 2.22mm (average diameter) x 1.35mm (D-estimated)

Total Weight - 0.29ct (estimated - see NOTE below).



Total Item Weight = 6.24 grams, Total Gemstone Weight = 0.29ct, Total Metal Weight = 6.18 grams (estimated)

NOTE: Limited gemmological testing inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
