Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, handfinished, raised 14ct white gold & diamond set, multistone ring.

Plain, narrow, low half round, tapered band, measures 1.89mm width (at base) x 0.84mm depth, tapers up to 12.72mm width (at top), with cut-out underrail, open back underneath.

Feature, "multi row cluster style" ring design. Comprising, seven rows across the top of the band, housing a total of ninety one round brilliant cut diamonds, claw set. The extended shoulders, of the band, taper up wide to the top, from both sides.

Polished finish, stamped "14k MH (partial), 1.50 tdw" - acid tested as 14 carat gold.

Finger size = Q1/2.

Ninety One claw set round brilliant cut diamonds, clarity is "P1 & P2"(mixed), colour is "G to I"(mixed), medium cut quality.

Dimensions = 1.69mm (average diameter) x 1.03mm (D-estimated) (smallest)

Dimensions = 1.85mm (average diameter) x 1.13mm (D-estimated) (largest)

Total Weight = 1.50ct (estimated - see NOTE below).

Total Item Weight = 6.41 grams, Total Gemstone Weight = 1.50ct, Total Metal Weight = 6.11 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
