### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One lady's, hand finished raised, 22ct yellow gold & gemstone set, dress ring. Plain, wide band, measures 3.97mm width (at base) x 0.60mm depth; with open back, underneath.

Feature, "dress style" design. Comprising, a raised oval shaped, top, with sun burst style surround, housing one round, faceted, natural sapphire, Illusion bead set. The extended shoulders, of the band tapers up wide to the top, from both sides.

Polished finish, stamped "916" - acid & x-rayed tested.

Finger size = L+.

The ring contains:

One illusion bead set round natural sapphire, colour is "medium dark - blue".

Dimensions = 4.44mm (average diameter) x 2.83mm (D-estimated)

Total Weight = 0.40ct (estimated - see NOTE below).

Total Item Weight = 5.18 grams, Total Gemstone Weight = 0.40ct, Total Metal Weight = 5.10 grams (estimated)

NOTE: Limited gemmological testing, inset. The culet of the sapphire, is protruding out through the back, of the setting, making the finger size an estimate. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weights of the gemstone are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstone require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
