## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 9ct yellow gold, gem set, dress style ring, of cast construction.

Plain, wide, tapered band of 4.25mm in width (at base) x 1.03mm depth, with hollow top and shoulders, and open back settings.

Feature 'cross-over' style ring design, housing five round brilliant cut diamonds, smallest to one end, channel set.

Polished finish.

Stamped '9K' - acid tested as 9 carat gold.

Finger size is V 1/2.

The ring contains:

- Five channel set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'H to I' (mixed).
- Dimensions = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness) (smallest)
- Dimensions = 2.20mm(Dia) x 1.34mm(D-estimated) x 2%(Girdle Thickness) (largest)
- Total Weight = 0.18ct (estimated - see NOTE below)

Total Item Weight = 6.31 grams

Total Gemstone Weight = 0.18ct

Total Metal Weight = 6.27 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
