Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 12ct white gold, dress style, gem set ring. Plain, wide, tapered band of 4.38mm in width (at base) x 1.34mm depth, with hollow top and shoulders, with open back settings.

Feature central four claw setting, housing one oval-shape cabochon cut natural emerald, claw set. Having two bezel settings, offset, each rub-over set with one round brilliant cut diamond. Surrounded by a 'swirl' design, claw set with forty-eight round brilliant cut diamonds. All secured between the tri-split shoulders of the plain and polished band. Each shoulder having twelve round brilliant cut diamonds, also claw-set.



Polished finish - stamped '750 38.2' - acid tested and x-rayed as approximately 12 carat gold. Finger size is M 1/2.

The ring contains:

One claw set oval shape cabochon cut natural emerald, colour 'medium to dark green'.
Dimensions = 10.50mm(L) x 8.78mm(W) x 5.31mm(D-estimated)
Total Weight = 3.82ct (estimated - see NOTE below)

Seventy Four claw set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'H'.
Dimensions (average) = 1.55mm(Dia) x 0.98mm(D-estimated) x 2% (Girdle Thickness)
Total Weight = 1.26ct (estimated - see NOTE below)

Total Item Weight = 11.13 grams - Total Gemstone Weight = 5.08ct - Total Metal Weight = 10.11 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The emerald is heavily included with surface reaching inclusions. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
