Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 9ct yellow gold and 9ct white gold, dress style, gem set ring.

Plain, wide, tapered band of 11.00mm at top to 4.18mm in width (at base) x 1.40mm depth, with hollow top and shoulders, and pierced 'window' style curved underrail.

Feature single raised central row, housing five round brilliant cut diamonds, channel set. To each side is a single row having eighteen tapered baguette cut diamonds, also channel set. Each shoulder having a raised central white gold rippled tapered section to the yellow gold plain and polished band.

Polished finish - stamped '9K 0.50CT' - acid tested as 9 carat gold. Finger size is T.

The ring contains:

Five channel set round brilliant cut diamonds, clarity 'PI', colour 'H'.

Dimensions (average) = 2.45mm(Dia) x 1.49mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.25ct (estimated - see NOTE below)

Thirty Six channel set tapered baguette cut diamonds, clarity 'Si & PI' (mixed), colour 'H'.

Dimensions (average) = 1.40mm(L) x 0.90mm(W) x 0.55mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.25ct (estimated - see NOTE below)



Total Item Weight = 7.26 grams - Total Gemstone Weight = 0.50ct - Total Metal Weight = 7.16 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
