### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 14ct yellow gold, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 2.80mm in width (at base) x 1.09mm depth, with hollow top and shoulders, and open back settings.

Feature central four claw setting, housing four round brilliant cut diamonds (largest), claw set with centre claw. Secured between the shoulders of the plain and polished band. Each shoulder having four round brilliant cut diamonds, channel set.

Polished finish - stamped '14K' - acid tested as 14 carat gold. Finger size is N 1/2.

The ring contains:

Four claw set round brilliant cut diamonds, clarity 'P1', colour 'H, yellow and brown tint'.

Dimensions (average) = 1.85mm(Dia) x 1.13mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.13ct (estimated - see NOTE below)



Eight channel set round brilliant cut diamonds, clarity 'P1', colour 'H to J, yellow & brown tint' (mixed).

Dimensions (average) = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.12ct (estimated - see NOTE below)

Total Item Weight = 3.17 grams - Total Gemstone Weight = 0.25ct - Total Metal Weight = 3.12 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
