Three diamonds are four claw chelier cross-over wire collet set side by side. Angled rub over set diamonds are displayed in the centre of each under-carriage and channel set in each upswept shoulder. The slightly round band measures 2.44mm wide. This item is of mass production cadprint cast manufacture. Size O. 3.70 grams.
