Single cut diamonds are rhodium plate bead set in the centre section and each side in curved rows and the synthetic rubies are channel set in opposite curved rows. The oval shaped bangle is hollow, hinged and has an integrated clasp with one figure eight safety clip. The internal diameter measures sixty millimetres.
