## 10K White Gold Diamond Ring

The rings central cluster contains nine round brilliant cut diamonds in claw settings. The shoulders are grain set with forty-six round brilliant cut diamonds and features milgrained textured edges. The floral designed under rail is two-claw set with two round brilliant cut diamonds. The band tapers down to from 5.00mm to 2.20mm in width at base. The inside of the ring is laser inscribed "10K", "MICHAEL HILL" and "1.00".


