## 10ct White Gold Diamond Ring

The rings setting head centres nine round brilliant cut diamonds in open bezel settings followed by borders of common-claw set single cut and round brilliant cut diamonds. The tapered band measures 9.30mm at the shoulders and tapers down to 3.00mm in width at base. The inside of the ring is laser inscribed "10K", "MICHAEL HILL" and "1.00".
