Description

9ct White Gold Ring Set

The rings pierced basket styled double cluster setting head centres a round brilliant cut diamond in four-claw setting. The cluster and shoulders of the ring contains fifty-four round brilliant cut diamonds in scallop settings. There is a height of 7.00mm above the finger. The band tapers from 3.50mm down to 2.20mm in width. The inside of the ring is stamped "375"

The accompanying ring has a curved head which is scallop set with eighteen round brilliant cut diamonds. The parallel band measures 1.25mm in width. The ring acid tested positive for 9ct.

1 = 0.14 carat (estimated weight). Shape/cut; round brilliant. Measurement; 3.30mm. Colour; I. Clarity; I1.

10 = 0.15 carat (estimated weight). Shape/cut; round brilliant. Measurement; 1.50mm. Colour; I-J. Clarity; I1.

62 = 0.62 carat (estimated weight). Shape/cut; round brilliant. Measurement; 1.00mm. Colour; I-J. Clarity; I1.
