The synthetic ruby is two claw one vee claw set with white gold claw chelier set along one side and curved around the top. The round shaped lower shank measures 3.22mm wide at the base and 1.20mm wide at the shoulders. This item is assessed as individually cast and assembled manufacture. Size N 1/2. 4.17 grams.
